O R D E R :

In the G.O. 1st read above, the Government have approved the list of Backward Classes (other than Scheduled Castes and Scheduled Tribes) and declared that the Casts and Communities specified in Annexure-I to the said order are Socially and Educationally Backward Classes for the purposes of Articles 15(4) and 16(4) of the Constitution of India. The Mudiraj/Mutrasi/Tenugollu community was recognized and included in the list of Backward Classes, at Sl.No.19, under Group-D.

2. The Chairman’s of Various Mudiraj Welfare Associations, Hyderabad submitted representations to change the group of Mudiraj community from “D” to “A” in the list of Backward Classes.

3. In the reference 3rd read above, the Chairman, A.P. Commission for Backward Classes, Hyderabad has submitted a report, recommending the Government to delete the entry MUDIRAJ/ MUTRASI/ TENUGOLLU at Sl.No.19 under Group “D” to G.O.Ms.No.1793, Education Department, dated 23.09.1970 and to include at Sl.No.1 under Group-A along with the existing castes “Agnikulakshatriya, Palli, Vadabaliya, Bestha, Jalari, Gangavar, Gangaputra, Goondla, Vanyakulakshatriya (Vannekapu, Vannereddi, Pallikapu, Pallireddi) Neyyala & Pattapu” in the existing list of Backward Classes.

4. The Government, after careful examination of the matter, have accepted the recommendations of the A.P. Commission for Backward Classes, Hyderabad and accordingly hereby order that the entry MUDIRAJ/ MUTRASI/TENUGOLLU community be deleted from Sl.No.19 under Group “D” and added at Sl.No.1 under Group-A along with the existing castes “Agnikulakshatriya, Palli, Vadabaliya, Bestha, Jalari, Gangavar, Gangaputra, Goondla, Vanyakulakshatriya (Vannekapu, Vannereddi, Pallikapu, Pallireddi) Neyyala & Pattapu” in the existing list of Backward Classes.

5. The Director, Backward Classes Welfare, Hyderabad and all the District Collectors are hereby directed to take necessary action accordingly.
